Other Conditions of Appointment:

1. Pay Scale:

The newly appointed Principals will be placed in the following pay scales, as per the notification issued by the Education Department, Government of Bihar, Patna, vide Sankalp Sankhya: 15/एन 1-20/2018-591 dated 06.03.2019, subject to changes notified by the State from time to time:

- Undergraduate Colleges:** The pay of Principals shall be equivalent to that of an Associate Professor, i.e., Academic Level 13A (Pay Band: ₹37,400–₹67,000 with Academic Grade Pay ₹9,000) with a rationalized entry pay of ₹1,31,400/-, plus a special allowance of ₹2,000/- per month.
- Postgraduate Colleges:** The pay of Principals shall be equivalent to that of a Professor, i.e., Academic Level 14 (Pay Band: ₹37,400–₹67,000 with Academic Grade Pay ₹10,000) with a rationalized entry pay of ₹1,44,200/-, plus a special allowance of ₹3,000/- per month.
- The existing pay scale of persons appointed as Principals shall be protected.
- Principals shall retain a lien on their main academic post and continue to receive notional promotions while functioning as Principals.

2. Tenure:

The tenure of appointment shall be five years from the respective date of joining, subject to the age of superannuation, whichever is earlier. This tenure may be extended for another term of five years based on a performance assessment by a Committee appointed by the University, constituted as per UGC regulations notified from time to time. After completing their term as Principal, incumbents may return to their parent organization.

3. Governance:

Their services shall be governed by the Bihar State Universities Act, 1976 (as amended up to date) and the Statutes made thereunder.

4. Reporting:

All the newly appointed Principals are directed to report their joining to the Registrar, L.N. Mithila University, Darbhanga within three (3) months from the date of issuance of this notification, failing which their appointments shall stand cancelled, and no claims will be entertained thereafter.

5. Documentation:

They are required to submit their relieving certificate and No Objection Certificate (NOC) in original from their employer at the time of joining.

6. Declaration:

They are required to submit a declaration from a First-Class Judicial Magistrate in the format attached herewith at the time of joining.

7. Service Agreement:

They are required to sign a service agreement with the University at the time of joining. Self-appraisal of performance shall form an integral part of the service agreement.

No Travel Allowance (T.A.) or Dearness Allowance (D.A.) will be admissible for joining the post.
